Dear Chief Justice McRuer:

You will recall the decision of the Canadian Bar Association at the meeting held in Windsor, August 19th, 1942, to make a tangible contribution to Canada's war effort.

An arrangement was made by which senior members of the legal profession were appointed in each Army District and Air Command across Canada to act as Honourary Advisory Counsel and to be available for consultation by the officer in charge of the service legal office.

At the time of the appointments, the Routine Orders were sent to each Counsel so appointed containing an expression of appreciation for their patriotic motive in consenting to act in that capacity. Now, on behalf of the Department of National Defence, I would like to express my sincere appreciation of the action taken by the Canadian Bar Association and I would be very grateful if you would convey the Department's gratitude to the gentlemen who so kindly consented to act as Advisory Counsel.
