Buy and Sell Agreements for Canadian Close Corporations

TO THE EDITOR:

I should like to point out that there have been changes in the law since Mr. Huberman prepared his article on buy and sell agreements which appeared in the last issue of the Canadian Bar Review. The Uniform Life Insurance Act has been completely rewritten, the revision coming into effect uniformly in all the common-law provinces on July 1st, 1962. There were included some important changes, not the least being limitations on the requirements of insurable interest. It is now recognized that the consent of the life insured is an adequate modern substitute for the insurable interest requirement that stemmed from the old English legislation designed to prevent gambling. One effect is the removal of the difficulty resulting from the considerable doubt as to the existence of insurable interest of one shareholder in the life of another to support insurance under a buy-sell agreement.
